GENERAL INFORMATION

Please note that:

1. The 2010 FIM Snowcross World Championship entry form has been published on the FIM Website from where it must be downloaded as follows:

2. The 2010 FIM Snowcross World Championship entry form must be completed electronically in capital letters

As a general rule, every rider wishing to participate in the 2010 FIM Snowcross World Championship must enter through his FMN and the FMNR/Organiser respectively. Entry requests/provisional entries can be made by e-mail or telefax to the FMNR/Organiser, but they must be confirmed with the duly completed official FIM entry form.

To be eligible for participation in FIM World Championships or Prize Events and in order to obtain a FIM licence, the riders must personally sign the "Acknowledgment and Agreement of the FIM Anti-Doping Code". All forms from under-age applicants must be counter-signed by their legal guardians.

It is the task of the FMNs to implement the collection of the aforesaid "Acknowledgement and Agreement of the FIM Anti-Doping Code" forms. For practical reasons, we have added this form to the entry form (see page 2 of the entry form).

Please note that the rider should always have with him a copy of his "Acknowledgement and Agreement of the FIM Anti-Doping Code", which has been certified by his FMN. We suggest that he keeps this copy with his FIM licence.

The rider must return his entry form, duly completed, to his FMN, who must always approve the entry. Consequently, pages 1 and 2 of the entry form must bear the stamp of the FMN concerned.

Once the entry has been approved, the FMN concerned must forward the duly completed entry form to the FMNR/Organiser as soon as possible.

The closing date for entry requests for the 2010 FIM Snowcross World Championship is 15 days before the meeting.

The number of entries is limited to a maximum of 66 riders: the first 8 riders of the final standings of the previous year's FIM Snowcross World Championship plus a maximum of 5 riders per FMN.
