GENERAL INFORMATION

Please note that:

1. The 2010 FIM Women's Motocross World Championship / FIM Veteran Motocross World Cup **entry form** has been **published on the FIM Website** from where it **must be downloaded** as follows:

2. The 2010 FIM Women's Motocross World Championship / FIM Veteran Motocross World Cup **entry form must be completed electronically in capital letters.**

As a general rule, every rider wishing to participate in the 2010 FIM Women's Motocross World Championship or FIM Veteran Motocross World Cup must enter through her/his FMN and YouthStream respectively.

The rider can enter for one, some or all of the meetings counting towards the 2010 FIM Women's Motocross World Championship or FIM Veteran Motocross World Cup. Entry requests/provisional entries can be made by e-mail or telefax to YouthStream, but they must be confirmed with the duly completed official FIM entry form.

If a rider has the intention of **participating in the complete FIM Women's Motocross World Championship or FIM Veteran Motocross Cup**, we suggest that she/he **puts a cross in the box "All meetings of the 2010 FIM Women's Motocross World Championship" or "All meetings of the 2010 FIM Veteran Motocross World Cup"**.

If a rider intends to **participate in one or several meetings** of the FIM Women's Motocross World Championship or FIM Veteran Motocross Cup, we suggest that she/he **indicates the respective meeting(s) under "Selected meetings of the 2010 FIM Women's Motocross World Championship" or "Selected meetings of the 2010 FIM Veteran Motocross World Cup"**.

To be eligible for participation in FIM World Championships or Prize Events and in order to obtain a FIM licence, the riders must personally sign the "Acknowledgment and Agreement of the FIM Anti-Doping Code". All forms from under-age applicants must be counter-signed by their legal guardians.



It is the task of the FMNs to implement the collection of the aforesaid "Acknowledgement and Agreement of the FIM Anti-Doping Code" forms. For practical reasons, we have added this form to the entry form (see page 2 of the entry form).

Please note that the rider should always have with her/him a copy of his "Acknowledgement and Agreement of the FIM Anti-Doping Code", which has been certified by his FMN. We suggest that he keeps this copy with his FIM licence.

The rider must then return her/his entry form, duly completed, to his FMN, who must always approve the entry. Consequently, pages 1 and 2 of the entry form must bear the stamp of the FMN concerned.

Once the entry has been approved, the FMN concerned must forward the duly completed entry form to YouthStream as soon as possible.

The closing date for entries for each meeting is 15 days before the meeting in question.

Up to 40 riders may enter in each 2010 FIM Women's Motocross World Championship or FIM Veteran Motocross World Cup meeting.

The Championship Promoter can enter up to 5 riders before the end of the technical verifications prior to the meeting.

The Championship Promoter must then inform the rider's FMN, the FMNR and/or the organiser in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

For these riders entered by the Championship Promoter, all listed entry conditions (apart from the closing date of entries) apply.
